Organizational Setting

The Agricultural Development Economics Division (ESA) conducts economic research and policy analysis related to all five of the Organization's strategic objectives (food security, sustainable agriculture, poverty reduction, inclusive food systems and resilient livelihoods); ESA provides evidence-based analytical support to national, regional and global policy processes and initiatives related to food security and sustainable agriculture; and leads the production of FAO flagship publication: The State of Food and Agriculture. ESA also leads large programmes at country level on agricultural policy monitoring, climate smart agriculture, agribusiness development, and food security information and analysis in support of national policies.

The post is located in the Agricultural Development Economics Division (ESA).

Reporting Lines

The Senior Economist reports to the Director, ESA.

Technical Focus

This position will lead a programme of work in macro food policy, integrating considerations of domestic and international trade, public expenditure patterns and basic farm and household microeconomics. The work will utilize quantitative economic analysis to provide evidence-based policy support that will help shape and implement FAO's Strategic Framework with an emphasis on poverty reduction, food security and nutrition, and sustainable agriculture and building resilient rural livelihoods. The programme of work is predicated on strategic partnerships with development agencies, donors and national governments.

Key Results

Leadership and conceptual thinking for the development and implementation of comprehensive technical, statistical and/or analytical frameworks to support the programme of work and related products, projects and services in accordance with the FAO Strategic Framework

Key Functions

- Plans, manages, or leads highly specialized or multi-disciplinary teams, leads, coordinates, and/or participates on Organization-wide, cross-Departmental committees, project teams, and working groups, and/or provides technical leadership/secretariat services on technical networks and/or international technical policy and standard setting bodies.
- Analyses global and country specific requirements as well as agricultural, economic, social, environmental factors to provide critical input into the FAO Strategic Framework, Programme of Work as well as Detailed Work Plans and the supporting budgets and/or resourcing strategies.
- Implements and monitors work programmes involving the conception and development of comprehensive statistical and/or analytical frameworks including early warning, medium and long term plans and strategies, leading edge tools, methods, systems and databases, critical indicators, and/or policy models, etc.
- Oversees and reviews data collection, validation, analysis and reporting activities to support the development of technical standards, international instruments, innovation, FAO flagship publications/yearbooks, and/or on-going programme development as well as technical and/or policy advisory services.
- Provides technical and policy advice to Member Countries and technical support to decentralized offices in the development and implementation of their programmes of work.
- Plans, organizes and participates in capacity development activities involving the provision of advice, technical assistance projects, training workshops, seminars, and meetings as well as oversees the development of related materials, on-line tools and information kits.
- Represents the Organization at international/inter-governmental meetings and conferences, advocates strategic partnerships, best practices, and increased policy dialogue and develops and negotiates effective working relationships/consensus and agreements with international and national partners.

- Leads and/or participates in resource mobilization activities in accordance with the Corporate strategy.

Specific Functions

- Leads a programme of work in the analysis of food and agricultural policies and their effects on the Sustainable Development Goals and food security at national, regional and international levels;
- Provides backstopping and country-level support in the formulation of national food security strategies and policies, with special attention to impacts on rural employment, household welfare, access to food, and sustainability and resilience of food systems and livelihoods;
- Communicates the results of various analyses to target audiences through a variety of information products, including media interviews, policy briefs, working papers, journal articles and books;
- Contributes to the management and work of the ESA division as a whole, ensuring that the quantitative food policy analysis work is well integrated with other Divisional economic research and policy analysis, as well as with the renewed FAO Strategic Framework;
- Ensures ESA's analytical and methodological work on food security and nutrition is properly contributing to FAO Strategic Framework Results in the Food Security and Nutrition domain, and, in particular, to FAO Strategic Objective 1 on "Contributing to the eradication of hunger, food insecurity and malnutrition" and Strategic Objective 5 on "Increasing resilience of livelihoods to threats and crises".
